One pivotal 2008 case for the firm involved a real estate developer who had lost an \$8 million judgment after more than two years of litigation. He hired Rakower Law in April 2008 to appeal this devastating decision. In September 2008, less than six months after having been hired, Rakower Law had won a complete reversal of the prior judgment. The case, *Yeh v. Lin*, was brought in New York State Supreme Court, New York County and bears Index No. 25071/05.
